Road Exploration and Experience Analysis of the Chinese-style Rural Governance Community Construction

Abstract: From perspectives of grassroots movements in the past and present, both domestically and internationally, Chinese peasants, under the leadership of the Communist Party of China (CPC) since its founding in 1921, have blazed a new trail in establishing rural governance communities with Chinese characteristics. In this process, revolutionary mobilization has served as the starting point, with political integration as the key. Under the leadership of CPC, the construction of rural governance communities has undergone several important stages, including foundation laying for the principal parts, institutional assignment, and reform and innovation. At present, history is in a critical phase of enhancement, improvement, and maturation. To be specific, CPC applied revolutionary mobilization in the new democratic revolution period to encourage farmers to take charge of their own affairs, which not only provided a basic precondition for the main components of rural governance communities but also explored different practical forms for their implementation.
