## Creation of Localized Concepts in Rural Governance Research: Problems and Reflections

**Abstract** As a premise and an approach of localization of rural governance research, concept creation, if made inappropriately, will inevitably affect related concepts, theories and doctrines in this domain. This article, based on the world outlook and methodology of dialectical materialism and historical materialism, as well as the fundamental position of Marxist political economy of "adhering to the people-centered philosophy", investigates and reflects on the current situation of the localized concepts in the study of rural governance, examining that there are generally three key problems in the research field. First, a simple application of the "state-society" binary analysis paradigm derived from the experience of some Western countries cannot truly meet China's reality; second, the research field has been continuously narrowed, and the construction of national
